- ◉ A graduate of Youngstown State University with a BE in Chemical Engineering, a certification in Nuclear Engineering, and Masters in Finance and Economics.

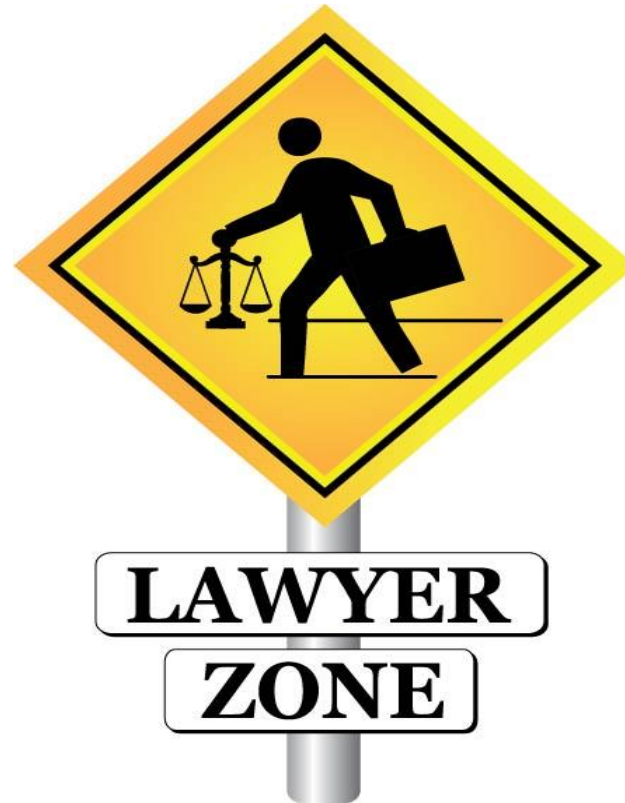
WHAT'S NEW?

- ◉ Another Billion Back, to be paid to eligible employers in the state insurance fund, 100% of 2019 premium starting in October, 2020.
- ◉ A second delivery of masks, free of charge, 5 masks per person, based on employee count provided by Department of Job and Family Services.
- ◉ First delivery of masks totaled over 20 million masks, paid for by BWC no impact of premium (\$ 1 per mask).

#8 - EXTRA VACATION TIME

Vacation next week in Florida is *10* days

You know you have a vacation coming up next week with your family. You only have 4 days vacation left for the year. I know! Getting injured will buy me those extra days!

#7 - WORKER'S COMP IS THE NEW OBAMACARE



I have a job that has healthcare. I don't like the job but I need healthcare. I know! A shoulder injury should be good for 3-4 years of free healthcare.

#6 - DUMB LIKE A FOX

This is true especially with “Chronic Offenders” or “Repeat Offenders”

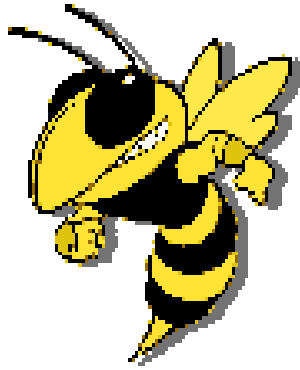
Did you ever notice how educated repeat offenders are with worker’s comp? They know when an employer needs to sign off or approve. They know the form numbers.

A badly injured worker with a deforming foot injury starts out as just a bad, feel sorry for the worker claim. The employer, employees do everything to accommodate the IW with the claim and expenses. Oh yeah, it was a 3rd party injury and a law suit. Can you say “Subrogation”?
